Violations may result in my receiving a verbal and/or written reprimand; restricting and/or suspending my participation in and/or my presence at Club activities; and/or the termination of my membership with the Club. I am prepared to demonstrate my knowledge and ability to play senior softball by being observed by members of the Club. I understand that I may not be allowed to play if my abilities or conduct are deemed to cause a health or safety problem for myself or others.
